Extinguishing media

Suitable extinguishing media : In case of fire, use water spray (fog), foam, dry chemical or CO₂.

Personal precautions, protective equipment and emergency procedures

Methods and materials for containment and cleaning up

Small spill : Stop leak if without risk. Move containers from spill area. Dilute with water and mop up if water-soluble.
