## Section 5. Fire-fighting measures

### Extinguishing media

### Personal precautions, protective equipment and emergency procedures

### Methods and materials for containment and cleaning up

**Small spill** : Stop leak if without risk. Move containers from spill area. Dilute with water and mop up if water-soluble. ### Precautions for safe handling
